### First Lutheran Church Council Minutes—October 9, 2019

The First Lutheran Church Council met October 9, 2019. Called to order: Meeting was called to order at 7:00 p.m. by President Tami Brownell.

**Devotions/Opening Go 'round:** Pastor Grant led discussion and prayer requests.

**Review and Approval of Minutes:** Motion by Hannah Johnson to approve the minutes of September 11, 2019. Seconded by Joyce Charlson. Voice vote. Motion carried.

**Council Development:** The council continued review of the Congregational Change cycle. We discussed confronting assumptions through leadership and the resulting losses that may be experienced.

### **Unfinished Business:**

- 1. Motion by Hannah Johnson seconded by Margaret Askelsen to hire Haylee Fishburn as director of God's Guitars for a wage of \$10.00 per hour. Voice vote. Motion carried. Joan Voigts presented information she received from Sumners Insurance Agency about our Safe Sanctuary policy. A contract will be drawn up between Haylee and First Lutheran and she will also be requested to sign the volunteer information form. She will be required to take an on-line course on reporting of child abuse.
- 2. Pastor Grant reported that there is no credit card fee. Consensus was to continue with the current card.

#### **New Business:**

- Council reviewed fourth quarter events with a focus on Stewardship month (November) and Harvest Festival Sunday. Motion by Joyce Charlson, seconded by Hannah Johnson to approve the letter and stewardship materials drawn up by Joan Voigts and the worship committee including the confirmation class serving brunch following the service on November 24. Voice vote. Motion carried. Lori Frink will send the stewardship information to members before October 18.
- 2. Set date for a congregational meeting on October 27 to approve the slate of officers on the ballot for next year. Set January 19 (storm date January 26) for annual meeting of the congregation and election of officers.
- 3. Council and Pastor Grant will begin organizing a winter event to include all three partner churches. Suggestions included worship, lunch, musical talent and activities at the Red Shed or other neutral location on January 26, 2020.
- 4. Discussion was held about incorporating more special music into our worship as we have many talented people at our services. Consensus was to speak with the new music chairperson following the election in January.
- 5. Motion by Joyce Charlson, seconded by Margaret Askelsen to continue web site agreement with Ryan Nail for 2020. Voice vote. Motion carried.
- 6. Motion by Joyce Charlson, seconded by Barb Mussman to approve use of the church on November 23 for Warm your Heart (confirmation students) to distribute winter clothing and blankets to anyone who needs them. Voice vote, Motion carried.
